- Imprisoning practitioners in a "Water Cell" where they are immersed in dirty water up to their necks, and no light is allowed in.
- Force-feeding highly concentrated liquid pepper and saline solutions to practitioners.
- Injecting large doses of drugs into practitioners to damage their central nervous systems.
- Exposing practitioners to bites from mosquitoes, poisonous snakes, and scorpions.
- Tying practitioners to a small iron bench approximately 20 cm. (6 in.) high. They are not allowed to turn their head, close their eyes, or talk.
- Stretching and tying practitioners' limbs to the four corners of a metal bed so they cannot move.
- Poking practitioners' fingers and breasts with sharp bamboo sticks.
- Parading practitioners through the streets to humiliate them in public.

The persecution of female Falun Gong practitioners is vicious and merciless. Police officers not only torture them but also rape and sexually abuse them. More stunningly, after the crimes perpetrated in Masanjia Forced-Labor Camp were exposed, and it was made known that 18 female practitioners were stripped and thrown into male criminals' cells to be gang raped, the perpetrators were awarded and promoted by Jiang's government!

This evil persecution has broken up tens of thousands of happy families. Thousands of children and adolescents have been hurt and seriously affected. Many children are detained along with their parents or put into orphanages. Many others, including infants, are left alone in empty houses, where they eventually die from starvation or accidents. Many young people are deprived of their rights to go to school, attend college, or find a job simply because they practice Falun Gong. Some of them are sent to labor camps or prisons, and several tortured to death.

Australian citizen and artist Zhang Cuiying was imprisoned for eight months after she peacefully appealed in China on behalf of Falun Gong. She suffered all kinds of torture. Canadian citizen Zhang Kunlun was sentenced to three years of forced labor only because he practiced Falun Gong exercises in a park. He was brainwashed and shocked with electric batons. With the help from the Australian and Canadian governments, and other concerned individuals, both have now regained their freedom.

In order to further persecute Falun Gong and justify their cruel actions, the Jiang Zemin regime devised the Tiananmen "Self-Immolation Incident." Just as the International Education Development Bureau announced in its report at the United Nations, "This government took out this so-called self-immolation incident that happened on January 23, 2001, in Tiananmen Square and used this as evidence against Falun Gong. We have reached the conclusion after watching a videotape on this incident, that this incident has however been completely orchestrated by the government.

We have copies of the videotape for distribution."

The facts presented here are only the tip of the iceberg. For the past two years, Jiang Zemin has been using his power as the national leader to launch an attack on Falun Gong. He is utilizing the entire governmental system and all the country's resources for his own purposes, including consulates and embassies abroad, claiming that he is acting in the interest of the nation and its people. He uses the state-controlled media to fabricate stories and slander Falun Gong. All deaths and murders of Falun Gong practitioners are reported as being the result of illness and suicide. By manipulating the police department and the judicial system, he has turned legal appeals and protests into charges of "disturbing the social order." Domestic terrorist persecution has become the order of the day.

At all costs, the deaths of tortured practitioners are kept away from the scrutiny of the outside world. Foreign correspondents' cameras and film are often confiscated, and no third-party investigation has ever been allowed. Practitioners' families are put under great pressure to remain silent; they are threatened and abused, often tortured. As a result, people are unaware of the state terrorism in effect right now. Even when citizens do become aware of it, they cannot run away fast enough, for fear of trouble. Falun Gong practitioners clarify the truth to people but are sentenced to jail without due process "in the name of the law." Through the "guilty by implication" policy, the government incites fear, prejudice, hatred, and violence against Falun Gong. People are encouraged to hurt each other. They are kept far away from traditional moral principles and good conscience. They are forced to oppose Truth, Compassion, and Tolerance. Indifference has taken the place of sympathy; hatred and narrow-mindedness have taken the place of compassion and forgiveness.

Yvon Charbineau, Member of Canadian Parliament, made the following comment about the persecution of Falun Gong: "I consider that this form of terrorism practised against the Falun Gong practitioners in China is no more acceptable than any other form of terrorism." Scott Reid, another Member of Parliament from Canada said: "I encourage the Chinese authorities, as I always do on these occasions, to take a look at the people who you're imprisoning and ask yourselves, how could these people possibly be anything other than the model citizens you would want every citizen to be and reconsider what you're doing. Ask yourselves whether you don't want to embrace these people, take them into the very heart of your country and your state and benefit, as we all can benefit, from absorbing these fundamentals, and valuable beliefs."

Jiang Zemin's persecution of millions of innocent Falun Gong practitioners has clearly demonstrated itself to be state terrorism. The persecution of Truth, Compassion, and Tolerance is to completely destruct the most fundamental values that define morality. This persecution must end; the harm this terrorism brought to humanity must stop. We are calling upon people of conscience all over the world to stop this brutal persecution and end the behavior of state terrorism.
