


# Sexual Abuse and Rape Used to Destroy Female Practitioners' Faith



**Female practitioners are stripped and thrown into male criminals' cells to be gang raped.**

The persecution of female Falun Gong practitioners is brutal. Police officers not only torture them but also rape and sexually abuse them. For example, they have been stripped, body searched, and beaten with electric batons in public. They have had their breasts punctured with iron wire. Eggplants, toothbrushes, water bottles, and hot pepper powder have been forced into their vaginas, in addition to electric batons. The police also torture practitioners' children and force pregnant practitioners to have abortions. They try to destroy them mentally and spiritually.

A female practitioner who was released from Masanjia Forced-Labor Camp said, "You can't imagine the extent of evilness there." More stunningly, after the crimes perpetrated in Masanjia were exposed, and it was made known that 18 female practitioners were stripped and thrown into male criminals' cells to be gang raped, the perpetrators were awarded and promoted by Jiang's government! The government rewarded the camp director with 50,000 Yuan [about US\$6,250; \$50 is the average monthly urban income in China] and the deputy director with 30,000 Yuan [about US\$3,750]. Government authorities also allocated money and ordered the jail to be expanded. Only because these female practitioners chose to practice Falun Gong and would not give up their faith in Truth, Compassion, and Tolerance did the persecutors pollute their pure bodies and devastate their dignity as human beings.

## Police dare to beat and rape female practitioners in the streets of Beijing, the Capital City of China

It was after 9 p.m. on May 14, 2001. A female practitioner was alone and pasting up Falun Gong flyers along the street from Dabeyao to the Yong'anli city canal. A plain-clothes policeman on patrol stopped her. He viciously groped her, using the excuse of conducting a body search. She didn't comply. She struggled to get free and ran down the street. He chased after her on his bicycle, and beat her fiercely with a rubber baton. She did not hit back but told him, "Falun Gong teaches people to treasure virtue and be kind. We are not bad people..." But he hit her even harder and without restraint. He bluffed and blustered, "My boss said not to let go of any Falun Gong practitioner. Today, I will kill you and throw your body into the city canal, or take you to the police substation."

This thug was in his 30s, about 1.65 meters tall, and quite strong. He brutally hit her for over an hour, bringing her to the verge of death. There were about a dozen passers-by who came to watch during that time. He then shouted, "She is a Falun Gong practitioner. She is an active counter-revolutionary. If I beat her to death, it will count as nothing." No passer-by dared to stop. She had heard policemen say in the past, "Jiang Zemin has ordered: 'Beating Falun Gong members to death is free from legal responsibility. Their deaths will be counted as suicides.'"
