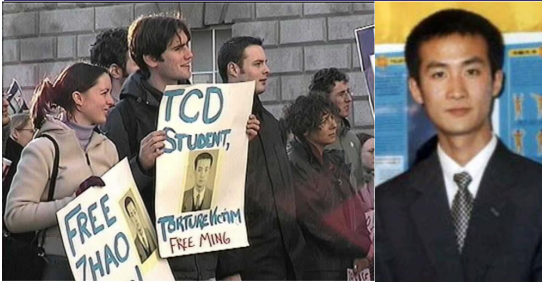


# Persecution Extends Overseas

On December 13, 2000, China sentenced United States resident Teng Chunyan to three years, for the crime of informing international journalists about China's illegal practice of detaining and torturing Falun Gong practitioners in mental hospitals.

Lin Shenli, a Falun Gong practitioner and husband of a Canadian citizen, was finally freed on Jan 23, 2001, after being imprisoned for over two years

in China. He was released with the help of the Canadian Foreign ministry, Members of Canadian Parliament, Amnesty International, and many kind Canadians. He was reunited with his wife in Montreal on February 25, thanks to the continued support from various organizations in Canada.



Canadian held in Chinese forced-labor camp: Professor brutally tortured, and jailed without trial just for doing exercises in public. He was sentenced to three years, but was released after two months under international pressure.

With the great support and the concerted efforts from the Canadian government, Department of Foreign Affairs, Members of Parliament, Senators, Amnesty International and other human rights organizations, the media, Montreal MP, Attorney Irwin Cotler, and all kindhearted people, Professor Zhang Kunlun, a former Montrealer, was released after serving only two months of his sentence.

## ZHU YING IS FREE!!!

Under pressure from Canadian Falun Gong practitioners, the government, members of Parliament, non-governmental organizations, attorneys, principals, professors, college students, and others from all walks of life, as well as from the objective reporting of the Canadian media, Chinese police had to free Canadian Falun Gong practitioner Ms. Zhu Ying. She had been kidnapped by the police at the Guangdong customs office. After losing freedom for more than 30 days, Ms. Zhu safely returned to Canada on June 21, 2001.
