Part I - Mr. Li Hongzhi and Falun Dafa

Mr. Li Hongzhi



Born in 1951, Changchun, Jilin Province, China, Mr. Li is the founder and teacher of Falun Dafa (also called Falun Gong), a spiritual discipline rooted in ancient Chinese culture. His teachings inform a spiritual awakening in China that has seen nearly 100 million people take well being into their own hands. In addition, people in some 47 countries now share in the practice. Li's writings and public speeches have taught that the realization of one's highest self lies in the cultivation of Truthfulness, Compassion, and Tolerance.

Mr. Li has received over 600 awards from various governments and non-governmental organizations around the world in recognition of his extraordinary contributions to humanity and society.

Mr. Li was nominated by more than 500 select professors and government officials in 14 countries, for the 2001 Nobel Peace Prize. For the second time, Mr. Li made the Norwegian Nobel Committee's short list.

Mr. Li was also nominated by over 28 members of the European Parliament for its 2001 Sakharov Award for Freedom of Thought.



Falun Gong is a traditional Chinese self-cultivation practice, which improves mental and physical wellness through a series of exercises, meditation and development of one's "Mind Nature or Moral Character" (*Xinxing*). Its gentle movements purify and open the body's energy channels, enhance energy levels, and strengthen and improve one's circulation. The movements are simple and easy to learn, yet exceptionally powerful. A tranquil, sitting meditation ends the exercise session. The exercises can be practiced with a group or alone—anytime, anywhere.

Falun Gong emphasizes above all the development of one's "Mind Nature or Moral Character" (*Xinxing*). The cultivation of *Xinxing* has many aspects: giving up negative behaviors, dealing with losses and gains, letting go of unhealthy attachments, and ultimately, aligning oneself with the essence of the Universe:

Truth, Compassion, and Tolerance (Zhen, Shan, Ren)

ZHEN Truth, Truthfulness, Return to One's True Self

SHAN Kindness, Benevolence, Compassion

REN Endurance, Forbearance, Tolerance

Falun Gong was introduced to the public in May of 1992. During the following two and a half years Mr. Li lectured tirelessly by invitation in almost every major Chinese city, giving fifty-four lecture series in all; many classes consisted of as many as nine or ten consecutive sessions, with the number of attendees ranging as high as four thousand.

The 1993 and 1995 publication of *China Falun Gong* and *Zhuan Falun* allowed a much wider base of people to learn Falun Gong. By 1996, Mr. Li's *Zhuan Falun* was among the nation's best sellers. A 1999 survey by the Chinese government determined that over 70 million people were practicing Falun Gong.

In April of 1995 Mr. Li gave his first lecture series outside of China, teaching the practice in Göteborg, Sweden.

In October 1996, Mr. Li traveled to the United States where he lectured for the first time, speaking publicly in Houston and then in New York.

The year 1998 saw Mr. Li lecturing widely around the world. By this time word of the practice abroad had traveled, and audiences swelled to several thousand. That year he spoke again in New York City; Toronto, Canada; Frankfurt, Germany; Changchun, China; Singapore; and Geneva, Switzerland. All of these talks were free and open to the public, and part of larger “insight and experience sharing” conferences put together by students of the practice.

Part II - Worldwide Recognition

Before the summer of 1999, the Chinese government actively supported and promoted the practice; Falun Gong was found to have significant effects on health while also improving character and morality more generally. The practice continued to grow at an explosive rate in China during the years that followed.

Mr. Li and his practice have triggered nothing short of a spiritual awakening in China. Tens of millions have, through Falun Gong, taken well-being into their own hands through traditional exercises and values. Mr. Li has taught that the ultimate goal of being is not the pursuit of material things or the fulfillment of self-interest, but instead the returning to one's original nature through self-cultivation. The teachings, at their simplest, are summarized as Truth, Compassion, and Tolerance—the primordial Great Law of the universe. That tens of millions could embrace such teachings under an atheist regime that shuns the life of the spirit is cause célèbre.

Mr. Li's practice not only offers a spiritual message with deep import, but also significant health effects. Those who take up the practice of Falun Gong typically report rapid, dramatic improvements in health. The entire spectrum of illnesses have been treated by genuine practice—allergies, digestive disorders, heart conditions, arthritis, skin conditions, and even terminal illnesses like cancer have all found relief or cure through the practice. Several surveys support this, along with the living testimonials of millions. Those who are already healthy find themselves enjoying less stress and more inner peace, improved immune function, better energy levels, more balanced emotions and better moods, improved sleep, and much more. Yet Mr. Li reminds practitioners that these are by no means the goal. They are instead but the byproduct of right living—living that accords with the laws of the universe, the path of self-cultivation, and powerful, holistic exercises. The goal is to become a better and better person, someone who brings goodness everywhere, to everything and to everyone.

Part III - The Persecution

The April 25, 1999 Incident Near the Zhongnanhai Government Compound in Beijing



The growing popularity of Falun Gong troubled the authorities in China. The fact that the number of Falun Gong practitioners exceeded the number of registered members of the communist party generated a serious concern among a few top leaders, especially China's president, Jiang Zemin.

As a result, in 1996, the official Chinese news agencies were ordered to start a propaganda campaign to slander and discredit Falun Dafa. Additionally, the public security bureau secretly ordered the banning of Falun Gong, which allowed for the illegal search, arrest of practitioners and seizure of their property and personal assets.

On April 25, 1999, as many as 10,000 practitioners from provinces around China peacefully gathered outside the central government's compound in Beijing. They requested the right to practice Falun Gong in a non-hostile and tolerant environment. This peaceful gathering was witnessed by all to be orderly and lawful.

This event marked the largest gathering in Chinese history whereby people peacefully appealed to the government. That evening upon completion of their appeal, the practitioners picked up all the trash in the area, and left without incident.

Burning and Destruction of Falun Gong Books and Materials



The event was widely covered by the western media. The Falun Gong practitioners' peacefulness and rationality impressed the world.

However, within the PRC, the fire of animosity against Falun Gong was ignited. A plan to eradicate Falun Gong was under way.

July 20, 1999, the nationwide crackdown on Falun Gong began. The resources of the entire state were utilized in an attempt to wipe out Falun Gong. In the first 30 days, the official newspaper, The People's Daily, alone published 347 articles against Falun Gong. Over 100 official TV and radio stations were flooded with propaganda programs against Falun Gong. Citizens were organized by their local government branches and their state run workplaces to watch the programs made by the Chinese Central T.V station. Even overseas Chinese embassies were ordered to do their part by organizing local Chinese scholars to condemn Falun Gong and to distribute anti-Falun Gong materials to local governments in their host countries. President Jiang Zemin himself took the opportunity to slander Falun Gong when he attended international meetings, and handed out propaganda booklets to the heads of all countries.

There is another side to the story, equally amazing, in its heroism and goodness. The practitioners of Falun Gong have, through the guidance of Mr. Li's teachings, not succumbed to the persecution against them. They have not resorted to violence at any time or in any way, refusing to treat their oppressors as their enemies. They have not given up hope or passively accepted the injustice, and instead actively and peacefully resisted. Millions travel to Tiananmen Square to appeal, as is their constitutional right, before their government and the world. Millions print flyers and banners and post them widely in their cities and villages so the truth may stand a chance of being heard. Millions go on hunger strikes while in custody to

demand an end to their maltreatment, willingly suffering the pains of hunger and thirst. All risks are taken knowing full well the punishment likely to follow for speaking out against injustice.

Police Beating, Dragging, and Forcibly Arresting Practitioners Making Appeals



It is impossible to know exactly how many practitioners went to Beijing to appeal. But on July 21st, the sports fields of the two largest Beijing sports stadiums, Fengtai and Shijingshan, were filled to capacity with thousands of arrested practitioners. That evening, a heavy rain fell in Beijing. The practitioners, showing concern for their captors, gave their own umbrellas to the policeman guarding them. It was reported that elderly women insisted on paying the bus fare for their ride into detention on the city buses used to

transport them, rather than see the city lose the fee. Their compassion and forbearance moved even the most iron-hearted policemen.

Despite the wide spread crackdown, there has not been a single case of violence, revenge or retaliation by any Falun Gong practitioner against their abusers.

Evidence of Brutality - Blood Stained T-Shirts



The practitioners' peaceful appeal only resulted in more intensified persecution directed against them. President Jiang Zemin took Falun Gong as his personal enemy and gave orders to destroy Falun Gong by any available means.

More horrible news continues to arrive from China. To date, at least 20,000 practitioners are being held in labor camps. We have confirmed that around 750 previously healthy practitioners have been confined to mental hospitals against their will, but believe the true number is in the thousands.

In the over two years of the persecution, hundreds of thousands have endured detention at one time or another.

A Partial List of Practitioners Who Have Died From Torture While in Police Custody



The persecution of Falun Gong continues to escalate. China's leadership has declared its intention to "eradicate" the practice in the upcoming months. On June 11, it created new "laws" to more severely punish those who resisted the ban on Falun Gong, including, even, punishment by execution. More and more, we are seeing that this persecution is targeting women, children, including an 8-month old baby, and the elderly as its victims.

As of November 15, 2001, at least 311 Falun Gong practitioners have been persecuted to death. This is an average of 10 deaths per month. In fact, sources inside the government place the true number at over 1,000. No one knows the exact number.

A Clandestine Press Conference in Beijing to tell the International Media



On October 28, 1999, a clandestine press conference organized by practitioners was held in Beijing. It successfully broke the news blockade imposed by the Chinese government and for the first time, the Western media had a chance to hear Falun Gong practitioners' personal stories.

Part IV - The Peaceful Appeal Worldwide

In the nearly two years since Falun Gong was banned in China, Mr. Li has been constantly defamed and attacked by the Chinese state-run media, and Chinese officials have called for his arrest and extradition. Yet he has remained firm in his commitment to virtue and nonviolence, consistently calling for a dialogue with the Chinese government and a peaceful end to the persecution of his students.

On July 20, 1999, Mr. Li published a statement in response to the crackdown. "Falun Gong is simply a popular qigong activity. It does not have any particular organizational structure, let alone any political objective. We have never been involved in any anti-government activities"

"We are not against the government now, nor will we be in the future. Other people may treat us badly, but we do not treat others badly, nor do we treat people as enemies."

This poem was written by Zhang Cuiying, an Australian citizen and Falun Gong practitioner, who was imprisoned for eight months simply because she went to China to appeal to the Government for their wrong decision to persecute Falun Gong. However, she was not given any opportunity to present her appeal and instead was jailed. In order to express her feelings, she wrote down her true experiences on paper while in her cell. However, the authorities would not let her write and confiscated any materials, which could be used to record her experiences. Nevertheless, these measures did not stop her from expressing herself. On the day she was released, when she walked out from the prison, she took off her jacket and displayed the T-shirt upon which she wrote the above poem.

A Mother's Appeal



Mrs. Ningfang Chen, formerly a member of the Central Philharmonic Orchestra, China's most prestigious orchestra, and a mother of two. She and her husband were both detained, each for 30 days. Her husband was expelled from the Communist party.

She was detained twice for that length of time. One of the times she was taken away at 1:00 am, when over a dozen policemen stormed their home and dragged her and her son from their beds. They then ransacked their home and confiscated all Falun Gong related materials, including their computer.

Her son, Gang, had been sentenced to a year in a forced labor camp, without trial, where he was tortured. His term was arbitrarily extended for six months, most likely because he refused to renounce his belief in

Falun Gong.

"My son is a very good person. As parents, nothing pains us more than not knowing what is happening to him. Recently, the number of Falun Gong practitioners who have died due to torture and abuse in labor camps has increased dramatically, but the Public Security Bureau has simply alleged that those people have committed suicide. We're very worried about our son's safety. We miss him and want him released as soon as possible. We are waiting for him to come home." – Mrs. Chen

Part V - International Support

Falun Gong Spokesman Invited to Speak at the National Press Club, Washington, DC



Erping Zhang, Falun Gong spokesman, gave a speech at the prestigious National Press Club on September 7, 2001. Mr. Zhang thanked the US House of Representatives and US senators, such as Senators Brownback (KS), Durbin (IL), Clinton (NY) and Schumer (NY) for their strong support. He called upon the American people to join in this just cause; to help us rescue Falun Gong practitioners persecuted in China. He also called upon China's authorities to unconditionally release all Falun Gong practitioners illegally detained in China.

Freedom House Awarded Mr. Li the 2000 Religious Freedom Award, Washington, DC



On March 14, 2001, Freedom House, a prestigious human rights organization co-founded by Eleanor Roosevelt 60 years ago, held an award ceremony at the conference hall of the U.S. Senate Foreign Relations Committee to honor Mr. Li Hongzhi and Falun Dafa, along with four other groups, as "defenders of religious rights".

This is the first time that a non-government organization, with the participation of members from the U.S. Senate and Congress and U.S. State Department, held an award ceremony honoring Falun Dafa and Mr. Li. This award, issued just before the meeting of the United Nations Human Rights Commission in Geneva, also drew the world's attention to Beijing's brutal crackdown on Falun Gong and other religious beliefs.

Support from Amnesty International.



Amnesty International, like many other human rights organizations, has stood by Falun Gong practitioners during difficult times. They are concerned about the escalating human rights abuses committed against Falun Gong practitioners by the Chinese government and are calling upon the Chinese government to stop the mass arrests, arbitrary detentions, torture, unfair trials and other human rights violations resulting from its official campaign against Falun Gong.

At a rally on the Capitol Hill on July 19, 2001, T. Kumar, director of Amnesty International's advocacy in Asia and the Pacific, urged President Bush to demand the release of imprisoned Falun Gong practitioners. Mr. Kumar delivered this message in his speech, "President Bush, you have a responsibility and an obligation to take the case of Falun Gong immediately before President Jiang Zemin before you visit China in October."

APA (American Psychiatric Association) Committee Calls for Investigation Of Chinese Psychiatric Abuses



China has committed psychiatric abuses through the misuse of mental hospitals and drugs to persecute Falun Gong practitioners. They have tortured mentally healthy practitioners to the point they incur brain or central nervous system damage or until death in some cases. According to Dr. Sunny Lu, a psychiatrist and Assistant Professor at the University of Cincinnati, more than 43 psychiatric institutions in China have engaged in psychiatric abuse, including five in Beijing. The Chinese government uses the police authorities to control psychiatric facilities in order to coerce Falun Gong adherents into renouncing their beliefs. Over 1,000 mentally healthy Falun Gong practitioners have been incarcerated and abused in mental hospitals. This is a far greater number of cases than the World Psychiatry Association cited in its investigation of the practices in the former Communist Russia.

A 32-year-old computer engineer Su Gang, was forcibly committed to a mental institution on May 23, 2000. He was intentionally injected with overdoses of psychiatric drugs to the point of death, on June 10, 2000. Fearing responsibility for his condition and possible death, the hospital officials released Mr. Gang and he died at home resulting from the treatment he received while detained at the hospital.

Abraham Halpern, M.D., professor emeritus of psychiatry, New York Medical College, condemned the psychiatric abuses by the Chinese regime and urged the World Psychiatric Association (WPA) to investigate and take action to stop the mistreatment of Falun Gong practitioners.

In his letter to the New York Times published on February 15, 2000, Dr. Halpern wrote, “Such blatant misuse of psychiatry was common in the Soviet Union for many years. It is vitally important for human rights groups, together with psychiatric associations, to organize against the pernicious practice of police agencies in China lest the horrors that prevailed in the Soviet Union in the 1970's and 1980's are reincarnated in China.”

One year later, Dr. Halpern wrote to the same newspaper on February 25, 2001 and asked the World Psychiatric Association to “act expeditiously and forcefully to protest this blatant misuse of psychiatry.”

Part VI - Worldwide Appeal

Chinese practitioners have moved and inspired people of all nationalities around the world. More and more people are living their lives according to the principles of Truthfulness, Compassion, and Tolerance. They support peaceful actions that help expose the true facts of the persecution against Falun Gong in China, calling for a justice and their rights to freedom of belief and assembly as given to them in China's constitution as well as the United Nations Universal Declaration of Human Rights of which China is a signatory.

Candlelight Vigil in Front of the Chiang Kai Shek Memorial Hall, Taipei, Taiwan



The Vice President of Taiwan, Ms. Annette Lu, made a brief appearance during the candlelight vigil on December 23, 2000, to express her best wishes for Falun Gong.

Recently, Taiwan president Chen Shui-bian was reported on October 29 from *Taipei Times*, to tell an AP journalist that if he had a chance to meet with China's president Jiang Zemin, he would ask the question: "Why can Falun Gong develop freely in Taiwan, while in China, it cannot?"

Celebrating World Falun Dafa Day in Hong Kong



One country two systems challenged –

In a shocking display of Beijing-style governance, more than 30 Hong Kong police and 10 authorities from the Food, Environment and Health Bureau rushed the group of approximately 10 Falun Gong practitioners at 4:30 on Saturday afternoon, November 10, 2001. The group was on their 46th day of a continuous peaceful, silent vigil drawing attention to the plight of imprisoned Falun Gong practitioners in China. The demonstrations are legal by current Hong Kong law.

Practice in Front of Eiffel Tower, Paris



As people from all walks of life are discovering greater health and spiritual well being through practicing Falun Gong and living the principles of "Truth, Compassion, and Tolerance." Falun Dafa is gaining widespread popularity and is embraced by people around the world. As world leaders met during the week of September 5, 2000, at the U.N. Millennium Summit, practitioners of Falun Gong arriving from Australia, Canada, Germany, United Kingdom, Sweden, Japan, Taiwan, and elsewhere gathered together in New York to express their indignation over China's continued persecution of Falun Gong in China. They called upon world leaders from all countries attending the Millennium Summit and people from all over the world to show their concern and support to the practitioners in China who are being brutally persecuted, urge the Chinese government to immediately stop the violent and inhuman persecution of Falun Gong practitioners and resolve the crisis in China through peaceful

dialogue.

The peaceful and compassionate conduct of thousands of Falun Gong practitioners' appeal not only attracted many journalists and pedestrians, but also made a strong impression on New York City policemen on duty. Nearly two thousand practitioners participated in the activities. There was not a single report of any damage made to any public facilities. Practitioners even collected all the trash and debris on the ground before they left. One policeman said to one of the practitioners: "You are the best! Falun Gong is the best!"

The Personal Appeal

Why We Walk?
